## **Christine Colley King, Thomas L. Melton and Dusty Philip Join Board of Directors of Lenox Hill Neighborhood House**

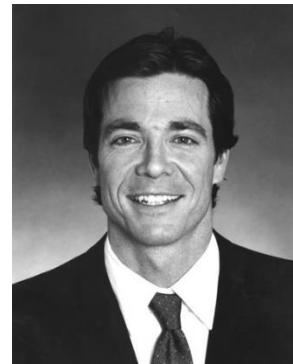
